








02HC018 Average Daily Temperature by Month

Purpose

CLOCA has been approved for \$2,177,000 in funding from Environment and Climate Change Canada (ECCC) over the next four years through The Great Lakes Freshwater Ecosystem Initiative. This funding aims to address significant environmental challenges affecting Great Lakes water quality and ecosystem health, aligning with Canada's commitments under the Great Lakes Water Quality Agreement. A primary focus is restoring and protecting critical coastal wetlands from climate change impacts. CLOCA has used data from long-term monitoring programs to plan for enhanced resilience in these areas and will now work on implementing these plans with the new funding. ECCC selected the Lynde Shores Conservation Area Restoration and Resilience Project due to CLOCA's thorough background work, partnerships formed, and the area's importance for both ecology and community (see staff report #5891-24 for background information on this project).

Key Takeaways:

Background

The Lynde Shores Restoration and Resilience Project addresses pressing challenges at Lynde Creek and Cranberry Marsh within Lynde Shores Conservation Area. It builds on extensive historical monitoring by the Central Lake Ontario Conservation Authority (CLOCA) through the Durham Region Coastal Wetland Monitoring Project (DRCWMP). Monitoring has highlighted ecosystem deterioration due to climate stressors, invasive species, pollution, and human activities, emphasizing the need for urgent conservation efforts. Despite its existing ecological, recreational, and cultural significance, Lynde Shores Conservation Area requires intervention to ensure it's ecological values and services are retained and more resilient to climate pressures.

Partnering with ECCC, CLOCA developed strategies to enhance wetland resilience against escalating climate impacts (see staff report #5891-24). Future projections predict more severe stressors such as extreme temperatures, fluctuating water levels, and increased precipitation, posing challenges to wetland resilience. The approach integrates scientific research, community engagement, and strategic planning to address complex ecological, social, and environmental factors affecting the marsh ecosystem.

Comprehensive restoration strategies tailored to Lynde Shores Conservation Area were developed based on current research and conservation practices. These strategies aim to enhance marsh ecosystem resilience, restore degraded habitats, and promote long-term sustainability through Nature-Based Solutions. Emphasis is placed on adaptive management and ongoing monitoring to ensure informed decision-making. The five proposed restoration projects for Lynde Shores Conservation Area include (1) Protective Wetland Features Enhancement, (2) Bathymetry Habitat Enhancement, (3) Wetland Creation and Enhancement, (4) Wetland Interspersion Restoration, and (5) Chimney Swift, Barn Swallow and Bat Habitat.

Community engagement and education are integral to the project's success. CLOCA seeks to inspire collective action, raise awareness, and foster partnerships to protect natural resources. Success hinges on collaborative efforts, innovative conservation strategies, and community engagement to ensure Lynde Creek Marsh's long-term sustainability.

While ECCC funding will support significant project phases, additional funding is needed for comprehensive implementation. This investment not only protects the environment but also preserves a vital social and cultural resource cherished by the local community. Given the urgency and local importance, CLOCA plans to commence work in early 2025.

Conclusions

The significant ECCC funding announcement represents a large and exciting step toward achieving the improved ecosystem health and resilience needed at Lynde Shores Conservation Area. CLOCA and ECCC recognize the importance of this area ecologically and socially and are investing in its long-term sustainability.
